1. SECRETARY-TREASURER

The term of the secretary-treasurer will expire during the Association's next meeting at the University of Washington (May 4-5, 1979). Nominations for the new secretary-treasurer should reach Susan Treggiari not less than two weeks before the start of the meeting, i.e. by April 19. Nominations must be signed by three members of the Association not belonging to the same institution (provided that different campuses within the same university system shall be regarded as being different institutions) and countersigned by the nominee.

2. CASSIUS DIO: AN HISTORICAL COMMENTARY

An historical commentary on all the surviving books, fragments and epitomes of Cassius Dio's 'Roman History' is being planned by Professors Michael Swan (University of Saskatchewan) and John Humphrey (University of Calgary), in consultation with several scholars across Canada.

A commentary of this scope is a vast undertaking that will occupy many classicists for several years. Under the guidance of the general editor -- who will co-ordinate the schedule of production, applications for grants, and the format and standards of the work -- eleven scholars will each be responsible for the treatment of a specific period of Roman History as presented by Dio. December 1988 is the provisional date for completion of the commentary, which will then be published in five volumes.
