

The President and Secretary-Treasurer may not be from the same institution.

MEMBERS REPORT



- Alan Bowman reports that the Faculty Centre for the Study of Ancient Documents at the University of Oxford has established a David Lewis Fund and Lecture Series in honor and memory of our recently deceased colleague. Each year, income from the fund will be used too pay the emoluments of a scholar invited to give a lecture relevant to the study of ancient history through inscriptional or other documentary sources. Colleagues interested in making donations to the fund or submitting comments or suggestions about the development of plans for the Centre or the lecture series are asked to contact Alan K. - Donald Lateiner reports the formation of a new organization, CANVBE (Classical Antiquity: Nonverbal Behaviors) whose aim is to promote and support awareness, research and publication about communications by gestures, postures, expressions and "everything else that goes without saying." 
