

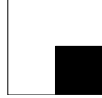

## PRESIDENT'S CORNER



At least one member reacted to my somber comments in the last newsletter rather like I respond to many mailings from animal welfare societies: the tales are so horrifying that one only wants to forget them. Some positive news is necessary to encourage active participation in any cause. With no criticism of my original message, our colleague deftly suggested another course: recalling that books in the field of ancient history are regularly listed as History Book Club selections or alternates, he wondered if we might not take some pride in these statistics. More than that, he offered to investigate. So, with my thanks for his nudge toward happier news, here are the findings.

During the past three years, 48 ancient history books were either major or minor selections. The list included Gibbon's *Decline and Fall*, Donald Kagan's *History of the Peloponnesian War*, new translations of Thucydides and of the Iliad and Odyssey and a couple of classical dictionaries. The rest were - in our investigator's words - "Genuine articles...on average, a selection on ancient history every month in recent years." Impressive figures! Perhaps we might extend this inquiry, asking major publishers to provide figures regarding books published annually on ancient historical topics. Ideas?

Another pro-active step would be to plan for a session at the annual AHA meeting *as an association* rather than relying only on enterprising individuals to submit proposals. As an affiliated society, we could hold a meeting, gaining a room without charge and a presence on the program. It is true that on several occasions, the AAH has hosted a reception; however, there has been no

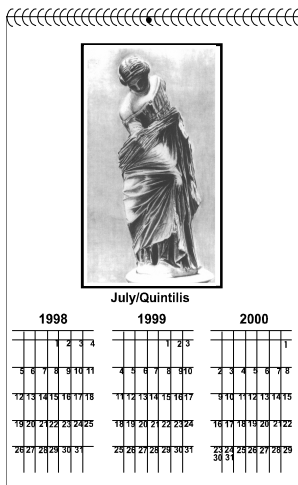

formal presentation. This year's AHA gathering in Seattle drew about 45 guests and, in fact, one topic of conversation was the virtual absence of formal sessions devoted to our field. Member Philip Kaplan has offered to help rectify the situation in the future. Who else will join this effort?

Help of another sort is urgently needed if we are to have an up-to-date Directory of Ancient Historians in the United States. For more than two years, Konrad Kinzl has labored (voluntarily, with no assistance or compensation) to revise the original directory produced by Richard Talbert and Bob Wallace. Changes and additions have been incorporated into an on-line version. But many people have not responded. If you have not checked your entry, please do and respond to Konrad (kkinzl@trentu.ca). And remember to inform him on an ongoing basis of changes, either of your own entry, or information you have of others. Please include the URLs of your home pages and of your department. We believe that it will be valuable to have a hard copy version of the directory as soon as possible.

Awards will be given to help younger members with costs of attending this year's annual meeting. This is possible through the generosity of a member who has donated \$500 for the past several years to help defray expenses of the meeting. To establish these subsidies for the future, however, our fund requires about \$3500 more in contributions. No amount is too small: a graduate student who joined the Association at the Seattle gathering presented a \$5.00 bill asking that the \$2.00 remaining after the \$3.00 membership fee was paid go into the fund. 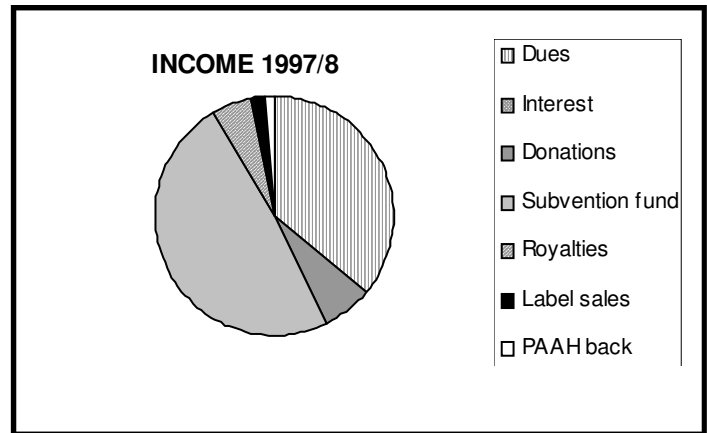

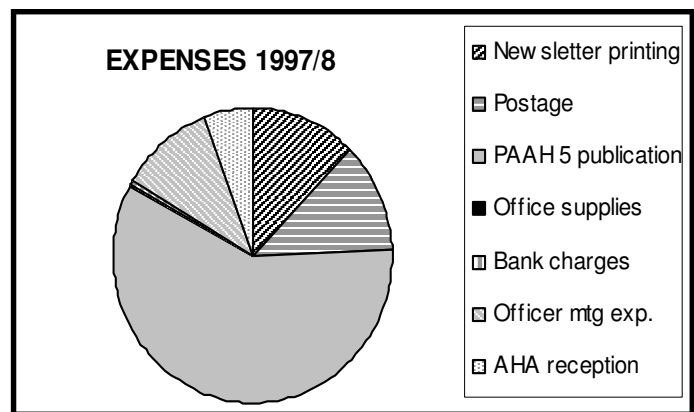

## Motion to Change Dues

As can be seen from the information above, costs for the Newsletter, for postage, and for the publication series are beginning to outstrip income. With several new publications in the editing and/or planning stages, we anticipate that there will be significant outlays over the next few years.

The President and the Secretary-Treasurer propose, therefore:

*That annual dues be increased to \$7.50 per year for regular members and \$5.00 per year for associate members.*

## MINUTES OF THE ANNUAL BUSINESS MEETING

Trinity University, San Antonio, Texas  
May 3, 1997

The meeting was called to order at 4:15. Carol Thomas, President of the Association, made two announcements: Alan Ward agreed to serve as Parliamentarian and Suzanne Martin agreed to take the minutes.

The Minutes of the 1996 Business meeting, as published in the spring newsletter, with one typographical correction, were approved unanimously.

**Secretary-Treasurer's Report:** The AAH currently has a total membership of 767, including 616 regular member, 141 associate members, and 10 institutional members. 652 of the members come from the USA, 62 from Canada, and 49 from overseas. In the future the fiscal year will run from March 15th to March 14th. The Association currently has a healthy balance of \$10,774.81. More and more members are paying dues in advance; members are reminded that prepayment has been capped at 5 years in advance.

Diana Delia thanked the AAH for the opportunity to serve during the three years of her term as Secretary-Treasurer.

Discussion about the budget included questions about money for subvention to encourage students and younger professionals to attend the annual meeting and the possibility of putting the Association's money in a money market or other higher interest earning account. The Secretary Treasurer responded that until now everything has been in a savings account earning 3% because of the need for liquidity, but it might be possible to transfer some funds to an account earning higher interest in the future.

**Future meetings:** Richard Mitchell said that the University of Illinois at Urbana Champaign was looking forward to hosting the AAH during the 1st week of May in 1998. The University of Illinois has a beautiful conference facility, Allerton Park, which will accommodate 83 people, although there will also be other accommodation available to those who wish. Expenses will probably be less than \$100 per person including food, accommodation, mailings, etc. There was discussion about possible topics for sessions, entertainment appropriate to the setting, and the pros and cons of having a session designed for graduate students. Richard Mitchell asked members to communicate their wishes and interests to him. Preliminary information about the 1998 meeting will be available on the AAH web page and questions can be answered through e-mail.

Zsuzsanna Varhelyi read a letter from Columbia University offering to host the AAH in 1999. President Carol Thomas

asked for a motion to accept the invitation. There was some discussion about whether to keep the meeting in early May (which will be more expensive) or to move the meeting to a later, less expensive, date. Colin Wells made a friendly amendment to the motion to keep the early May date. After discussion of concerns about expenses, including the possibility of providing some subsidy for younger members, the motion passed unanimously.

Carol Thomas asked the members for informal response to the idea of accepting an invitation to hold the annual meeting in Hawaii in 2000. There was positive response but other invitations and potential hosts are also welcome.

**Publications:** Carol reported that the revision and update of Chester Starr's volume for the AAH will be distributed to all members whose dues are paid up and a new volume on Makedonika by Eugene Borza is also forthcoming. She also announced 4 more volumes in the AAH series which are in preparation: a collaborative work by Stan Burstein focused on modern issues such as Gender and Ethnicity; a critical bibliography of works on Alexander the Great by Ernst Badian; a work on Ancient Law by R. Sealey; and a volume on the Roman Army by Colin Wells. In addition, Carol introduced Richard Burns of Regina Books and told the membership that he was helpful and willing to work with individual members on their own projects.

The Directory of Ancient Historians is currently "frozen" while Konrad Kinzl is out of the country, but Carol made a plea for members to submit up-to-date information. Konrad Kinzl has been awarded the Editors Choice award for his Web site based on the high quality and usefulness of the site, and the Association voted unanimously to send a formal expression of thanks to Professor Kinzl for his work on our behalf.

**Electronic resources:** A committee composed of Pat Dintrone, Mark Northrup, and Vanessa Gorman demonstrated some of the possibilities

which will be available in the (near) future. The AAH web site is currently being maintained by Shawn Ross, a graduate student at the University of Washington. The main page and a feedback form for comments should be available on the web by mid June. The Committee also distributed a Survey of Electronic Resources Preferences in order to better identify and serve the needs of members. Among the questions raised in discussion included potential ways to use the computer for communications, use groups, chat groups, etc.

**Election:** Pat Dintrone and Frank Holt were nominated to run for the office of Secretary-Treasurer and Pat Dintrone was elected for a 3 year term. The Association unanimously voted its appreciation to Diana Delia for her service as Secretary Treasurer during the past 3 years.

**Announcements:**

Gene Borza was unable to attend because of the aftermath of the floods in Fargo, North Dakota. His new house is on the Red River but thanks to hard work and good fortune they were spared serious flood damage. His address is 3602 River Dr. South, Fargo, N.D. 58104

Some US subscribers to the Ancient History Bulletin were accidentally overcharged and those who were overcharged will receive a rebate next year.

Stanley Burstein proposed that the Association express its thanks to our generous host, Colin Wells, and his associates at Trinity, for an excellent meeting. The following was approved unanimously:
