PRESIDENT'S CORNER

★The subvention fund has reached AND surpassed our initial goal of \$10,000! Contributions of every amount have realized that feat - once thought daunting and unrealistic - in

little more than a year's time. Having just watched various versions of Dickens' "Christmas Carol," let me say "Bless you, everyone." In the future it will be possible to make four annual grants to younger members to assist with the cost of attending the annual meeting. ★Two publications are on their way to becoming accomplished goals: the *Directory of Ancient Historians in the United States* and James Hooker's essays on *The Coming of the Greeks* are in the hands of their respective

printers. All paid-up members will receive a copy of the *Directory*; other copies may be purchased from Regina Books. The *Essays* are the second special publication of the AAH. (You will remember that the first is *Makedonika*, essays by Eugene Borza). Copies will be available through Regina Books, at a special price to members.

★The AAH has a new goal, namely establishing closer ties with other related organizations. Three members have agreed to serve with me on an ad hoc committee to achieve this end. A first step will occur at the AHA annual meeting in Washington D.C. where we will host a reception (see p. 2) on Saturday, January 9th from 4:45 to 6:30. Roughly thirty minutes of that time will be given over to discussion of proposals from the ad hoc committee. There will also be ample time for ordinary conversation and I hope to have copies of our new publications. Do come; our receptions, like our annual meetings, are lively occasions.

SPRING MEETING PLANS

The 1999 annual meeting of the Association will be held in New York on May 7-9 at Columbia University. Because the Managing Committee of the American School of Classical Studies at Athens will be meeting the same weekend, our program will be arranged to allow members of the Association who are on the Managing Committee to attend both meetings.

There will be three sessions. The meeting will begin with a session on the economy of the Greek world in the Classical and Hellenistic periods on Friday the 7th from 3:30-6, with the first paper to be given by Sitta von Reden (University of Bristol). This will be followed by a reception.

On Saturday morning the ASCSA meeting will be held, and our second session will be held from 2:30-5:30, on the family in late antiquity. The first paper in this session will be given by Judith Evans-Grubbs (Sweet Briar College). It will be followed immediately by the annual business meeting and then by a reception and dinner.

The third session, on Jewish history under the Roman Empire, will be held on Sunday from 9:30-12:00. The first paper of this session will be given by Seth Schwartz (Jewish Theological Seminary of America). The meeting will conclude with Sunday lunch.

NOMINATION FOR AAH PRESIDENT

Richard Talbert has been nominated for the office of president according to the procedure set out in the constitution of the Association.

Others wishing to make nominations are reminded that nominations must reach the Secretary-Treasurer not later than two weeks before the first day of the Annual Meeting at which the vote is to be taken. Thus, the deadline for nominations is April 22, 1999.

Nominations must be signed by three members of the Association not belonging to the same institution [different campuses within the same university system shall be regarded as being different institutions], and must be countersigned by the nominee. The President and the Secretary-Treasurer shall not belong to the same institution.

GRANTS-IN AID AVAILABLE FOR ATTENDING THE AAH MEETING

Thanks to the continued generosity of our members and friends, it will be possible to continue financial support to several younger members who wish to attend the annual meeting at Columbia University this coming May 7-9.

Two or three awards of \$200.00 each will be available. Applications are accepted from members of the AAH; senior members are encouraged to bring this announcement to the attention of graduate students or junior colleagues who are potential members. The procedure for application is as follows:

1. Applicants must be advanced graduate students pursuing degrees in ancient history or faculty holding initial (untentured) positions.
2. Applications should contain a curriculum vitae, brief letter stating the applicant's interest in attending the meeting, and one letter of support.
3. The deadline for receipt of all materials is **FEBRUARY 15, 1999**. Results will be announced by mid-March in order to give awardees adequate time to make arrangements to attend the meeting.

OPPORTUNITIES IN NUMISMATICS

The American Numismatic Society announces a variety of study and fellowship opportunities.

The 47th **Graduate Seminar in Numismatics** (June 15-August 14, 1999). Designed to familiarize students with numismatic methodology and scholarship, this seminar is an intensive program of study including lectures and conferences by specialists, preparation and oral delivery of a paper on a topic of the student's choice, and actual contact with related coinages. Applications accepted from students with at least one year of graduate work in classical studies, history, economic history, or related disciplines and from junior faculty with an advanced degree in one of these fields. Stipends of \$2000 are available to citizens or permanent residents of the U.S. and Canada. The ANS will endeavor to provide airfare for each student.

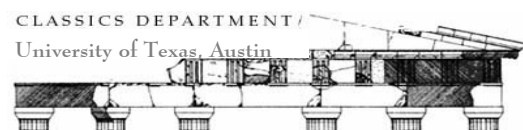
ANS Graduate Fellowship. \$3500 awarded to a graduate student in humanities or social science who has attended an earlier ANS Graduate Seminar and who has completed the doctoral general examinations and is writing a dissertation during the academic year 1998/9 on a topic in which numismatics plays a significant part.

Frances M. Schwartz Fellowship to support the study of numismatic and museum methodology at the ANS. Applicants must hold the BA or equivalent. Stipend varies with term of tenure (normally an academic year), not to exceed \$2000.

Donald Groves Fund to promote publication in the field of early American numismatics (material no later than 1800). Funding is available for travel, research, and publication costs.

Fellowship in Roman Studies provides a fellowship of up to \$5000 to promote the use of ANS collections and library in connection with studies of the Roman world. The fellowship supports extended residence in New York and work in the Society's cabinet and library in support of a substantive research project. Applicants must be U.S. citizens or affiliated with a North American institution of higher learning, demonstrate academic competence, and submit a detailed proposal. This work may or may not be in pursuit of a higher degree; preference is given to those seeking advanced degrees.

NEW PROGRAM IN ANCIENT HISTORY

The Department of Classics at the University of Texas at Austin announces the creation of a new **Graduate Program in Ancient History**. The Program in Ancient History is set up to provide students with training in ancient history and historical methods, with a strong foundation in classical languages and literature. Specialized exams in ancient history are individually set to reflect students' interests. Areas represented by faculty include Bronze Age scripts, archaeology, epigraphy, numismatics, papyrology, political, social and cultural history, economy, historiography, ancient law, medicine, and religion. The training is designed to make students competitive for ancient history positions in both Classics and History Departments, as well as for generalist positions in Classics with an ancient history emphasis.

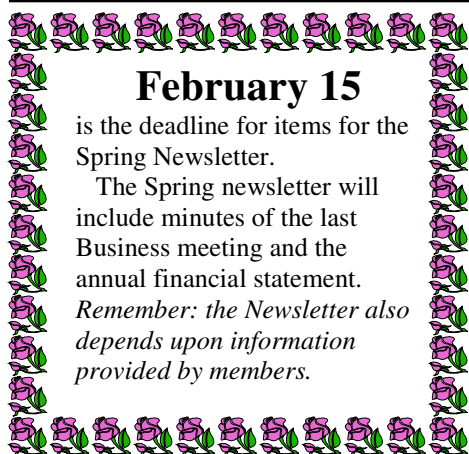
JOB ANNOUNCEMENT
