

In connection with the meeting, I would like to announce the recipients of the Subvention grants-in-aid. We were pleased to be able to support four individuals for this year's meeting: Rachael Goldman from CCNY, who is also the recipient of the Betty Coate Award; Christopher Furhmann, from the University of North Texas; Michael Helfield from the University of Toronto; and Brian Turner from UNC, Chapel Hill. I would also like to take the opportunity to appeal for donations to the Subvention Fund, which is a vital part of our ongoing program. My thanks also are due to the Subvention Committee (Denise Demetriou, John Lee, and Randy Howarth) for their hard work.

Please note the motion calling for the establishment of a Web Coordinator for the Association on p. 8. As I commented in the last Newsletter, there has been a growing amount of IT work required of the Secretary-Treasurer, which is not strictly part of the brief for the job. Randy has done an outstanding job with this, but we need someone with both the specific expertise and dedicated time to deal with these functions. A consensus of the former Presidents agreed, and the proposal is for a two year renewable appointment. There has been interest expressed in this already from the last Newsletter, and the proposal will be discussed and voted on in the upcoming business meeting.

Minutes of the 2008 meeting held at the University of South Florida

Called to order 4.30 PM by Jennifer Roberts.

2007 minutes with one spelling correction -change Bryce to Brice-approved (Borza, Hall).

President J. Roberts gave a brief overview of the AAH, its purpose and activities, for the benefit of newer members and attendees. In this context, a discussion about the Directory of Ancient Historians developed. Concerns were raised that it was outdated. Greg Anderson volunteered to take a leadership role and assign regions. Suggestion: links to web pages and sample syllabi. Q: shall there be included historians in Canada? A: Depends on K. Kinzl and G. Anderson. Motion of (Harl, Murray) carried that it be the sense of the meeting that Canadian historians be included. On the recent passing of colleagues; these names were mentioned: Helen Bacon, Zeff Stewart, and Nicholas Coldstream. Roberts called for a moment of silence.

S/T R Howarth report:

Finances : Balance of operating funds in Princeton was 18, 837.76. Total income from Princeton to USF meetings was 4504.60 (Dues, 3,065.21, Royalties 626.69, Label Sales 150.00, CD interest 662.70). Total expenses was 3815.49 (Newsletter 509.55, Postage 640.52, Conference Expenses 1111.42, web services 54.00, down payment to print PAAH #9 1500.00). Balance of general funds as of USF meeting was 19, 526.87. Balance of Subvention Fund after 2007 disbursements was 16, 012.31. Investment gain was 1307.88, donations were 780.00, disbursements in 2007 were 1500. Balance of fund after 2008 disbursements was 16, 585.19.

Membership: More vigorous reminders have culled inactive names from membership list. Member totals down to 597 from 644, of which 501 is US, 50 Canada, 46 misc. 121 behind on dues (from 188 in 2007). 415 on virtual mailing list (from 364 in 2007). 96 on electronic newsletter only (from 26 in 2007).

Web site and Ad hoc web committee report by Howarth

The web site platform has been improved rendering moot many of the issues brought up in the previous year. Howarth has redesigned the website substantially. The site looks much better than before and now has Pay Pal for the convenience of all members but especially off shore members. Total costs are about \$100 a year plus Pay Pal commissions. The potential still exists to use the site to provide digital access to PAAH back numbers and/or other potential revenue generators. Howarth promises to keep working on this and the continued digitization of archival documents, many of which are now already up on the site.

Subvention Committee report by chair Lindsay Adams. For the 2008 meeting, grants were made to six individuals (Seth Bernard, Miles Doleac, Danielle Kellogg, Jeremy LaBuff, Mark Thatcher, and Georgia Tsouvala) for a total of 1500.00. Lindsay Adams' term on the committee expires with this meeting. John Lee is appointed to rotate on. Denise Demitrious moves up to chair the committee (S/T is *ex officio* third member). Adams reiterated an appeal for donations to the fund. Roberts underscored that appeal.

Publications Committee report by Roberts (for Brice, Chavalas, Garfinkle, Roberts, and Thomas).

PAAH #9 is in the mail, some members have already received their copy. Applause to the editor Timothy Howe (present) from the membership. K. Harl and C. Wells have undertaken to collaborate on an Army and Frontier volume. Late Antiquity needs a new author. Law volume still in discussion, new ideas are solicited. Brice and Roberts making progress on a military history volume. Ancient World History volume may be spearheaded by M. Chavalas.

Publisher transition coming soon. R. Burns of Regina planning to retire; Georgias Press interested in taking over. Discussion ensued on potential retention of e-publication rights.

Presidential Race. One of the two properly nominated candidates, Ken Harl, withdrew his name from nomination. The remaining candidate, W. Lindsay Adams, was declared winner by rule, his office to begin at the conclusion of the meeting. The current president, Jennifer T. Roberts, congratulated Adams, noted Harl's long service to the organization, and thanked the body for her own opportunity to serve in a significant manner. A poem (published verbatim in the September 2008 newsletter) was read by the S/T to Roberts.

Two of the three Ballot issues (as moved and seconded in advance and printed in the Spring 2008 newsletter) were passed unanimously

Item 1: That the constitutional changes printed in the Spring 2008 newsletter be made

Item 2: That the membership dues be increased as outlined in the Spring 2008 newsletter.

Item 3: withdrawn

#### Old Business

Leanne Bablitz presented some information concerning hotel pricing and logistics for the 2009 meeting in Vancouver as well as the likely array of panels. Discussion arose concerning panel time and discussion formats. A consensus from the floor emerged that fewer papers with longer discussion opportunities was preferable. Leanne noted that the CAC conference ended on Thursday and that their banquet would be on that Thursday for those of the AAH who wanted to participate.

#### New Business

Lindsay Adams invited the AAH to the University of Utah for the spring of 2010. The specific dates: April 14-17. He made a brief presentation concerning transportation, restaurants, panel venues and hotel choices. The invitation was accepted unanimously (Ward, Harl).

Motion of Thanks to the Promoters of the 2009 meeting passed unanimously (Adams, Nimchuk)

As was the Motion to adjourn (Cargill, Adams) at 5.25 pm.

## AAH 2009 Annual Meeting: Accommodations and Logistics

Transportation: For US academics, remember you are travelling to a foreign country. **BRING YOUR PASSPORT**. The airlines and border crossings keep changing their policies; the easiest is just to use your passport. If you don't have one – make sure you check what the ID requirements are for your travelling method. As for flights, book early to get the best rates. You can fly directly into Vancouver International Airport which is served by many major airlines. Taxis to UBC from airport: \$35-40. City bus to the campus (takes a bit longer but is actually pretty painless): \$3.50. See website below for directions. If you're planning to rent a car and perhaps stay a bit longer in the area, you may want to consider flying into Seattle and getting your car there and then driving to Vancouver. It can make a big difference to the cost of the plane ticket if you're flying from a US location. The drive is 2 hours (Seattle to Vancouver) – but you must add to that the border crossing which can range in wait time from 20 minutes to 3 hours depending on what is going on in world politics and holidays.

Hotel: A block of rooms have been set aside at the University Conference Centre. We have booked two room styles with prices ranging from \$49/per night to \$139/per night. All have kitchen access. All our events will be within a 15 minute walk of the rooms. I encourage everyone to stay on campus – the bus system is excellent for getting off-campus, and it is nice to have a nap after lunch before the next session! Our room block is being saved for us until April 11, 2009. So book your room by then!

**NB: IMPORTANT CHANGE** Due to renovations, of which I was not notified until recently, our room block has been moved. The room types are identical, and we are actually going to be in a much newer building. However, the location on campus has changed, which makes the information provided in the last AAH paper newsletter outdated. Our room block is no longer located directly across the street from the bus loop. It will now be a 5-10 (depending how slow you are) minute walk from the accommodations to the bus loop. I do hope that this will not be a problem for people. When you book your room, the address will be something involving "Marine Drive". This is the new location. As we get closer, we will be putting up a map for you to use when you are arriving. To select your room on line and to book, use this link [RESERVE ROOM](#) (once you're in the website click on "check availability" to see the room styles available) If you wish to book by phone, call the Conference Centre at (Toll-Free) 1 888 822 1030. As usual, remember to mention that you are attending either the CAC or the AAH conference when you book.

For those who want to stay downtown and either take a bus or cab to campus I can recommend two hotels that offer different downtown experiences. The Sylvia Hotel is an old Vancouver hotel that is located on the beach (English Bay). The buses aren't the easiest from there to campus, but they exist (by bus allow a maximum of ¾ hour each way door-to-door). If you don't mind a bit of a struggle....it's a beautiful location. Website: <http://www.sylviahotel.com/>. If you want to be downtown with very good bus connections (you can get to campus by bus in 25 minutes) and close to shopping I would suggest The Holiday Inn. Donald Lateiner spoke on Valentine's Day to an overflow audience for a panel on "The Science of Kissing" at the American Association for the Advancement of Science in Chicago. His topic was "Greek and Roman Kissing: Occasions, Protocols, Methods, and Mistakes." Other topics included the chemistry of kissing (oxytocin, saliva swapping), neuron mirroring, etc., but Lateiner addressed Ancient Social, Deferential, Familial, as well as the expected Erotic occasions and procedures. The idea of kissing as a source of Roman defamation and numerous slides of ancient Near Eastern (proskynesis), Greek, and Roman kissers excited the audience. He discussed the apparent Mentagra outbreak that provided the Flavian poet Martial with so many poetic opportunities to grow anxious and decline social kisses on the Roman street.
