### In memoriam

**Ernst Badian:** Harvard Professor Emeritus Ernst Badian, a founder of our organization and one of its guiding spirits for several decades, died on February 1 after a fall in his home. #### **Ernst Badian: A Personal Note**

Ernst Badian was a remarkable individual, and this will be only one of many tributes to him. Many of his roles in life will be celebrated in the next few months: as a scholar, a mentor, a colleague, a friend and a family member. In all of them he was a singular presence. In an age where many people specialized in one role or another, one field or another, one time period or another, Ernst Badian did it all, with singular devotion and talent. He was unmatched in all of them.

I want to concentrate on one of those roles, which affected us and so many in this profession beyond the scope of what most people, even those who knew his scholarship, might realize. Ernst was the founder, author of the constitution and the presence whose vision drove and still drives the Association of Ancient Historians. This grew out of a series of regional meetings beginning in 1969 at McMaster University, organized by Professor George Paul, and his colleague Edward Togo Salmon, at which Ernst was present and for which he organized a second conference the next year at SUNY Buffalo. These continued as informal regional meetings over the next three years at the University of Michigan, The Pennsylvania State University and the University of North Carolina at Chapel Hill. But it was Ernst Badian, at the Harvard University meeting in 1974, who formally organized these informal meetings into the Association of Ancient Historians.

His intent was to base this on a new model, one in which all the scholars in the Ancient and Classical Studies would meet with one another in a friendly social setting, and share their work all together in plenary sessions. This was done so that everyone would of necessity learn of the current work in ALL of the fields, open a dialogue across the full range of Ancient Studies, inform one another's work, establish networks, and introduce younger scholars both to the field and to its senior scholars in a collegial atmosphere. He wrote the constitution for the Association to insure that his vision of who we are, and what we could be on a professional, collegial and personal level would endure.

Ernst's efforts have succeeded beyond anyone's expectations, save probably his own. The Association will be meeting this spring for the 37<sup>th</sup> time since its formal inception at Harvard. It has grown to include almost 750 members in the United States and Canada. The reputation of the Association for fostering both scholarship and nurturing young scholars into the field is well known. It publishes a series of scholarly and collaborative works designed to keep all the members abreast of developments throughout the field. In all of these things it encompasses not only the vision of its founder but embodies in that the kind of scholar, mentor, friend and colleague Ernst was. As a mentor and teacher, then, Ernst's "singular devotion" insures that his vision will not remain singular and will affect many more students and scholars than simply those who had the privilege to study with him or know him personally. He has left a legacy that continues and will continue to shape the profession through new generations of students. He will be greatly missed.

Bob Kebric wants those members who were using *Roman People* in their classes to know that it will now be published by Kendall/Hunt and will be available for Spring 2012. *Greek People* continues to be published by McGraw-Hill but will also be taken over by Kendall/Hunt in future. Both books, which are also being translated into Chinese for distribution in China by Beijing International Publishing Company, will subsequently appear in a 5<sup>th</sup> English edition through Kendall/Hunt.

Bob also wishes members to know that the proceedings of the first ever conference on the Hellenistic historian, Duris of Samos, will be published in 2012 by Presses universitaires de Paris Ouest Nanterre. The conference was organized by L'Ecole normale supérieure and was held in Paris in November, 2010. It included sixteen presenters from L'Ecole, the Sorbonne-- as well as other representatives from the University of Paris and French universities-- Würzburg, the University of Rome, the Catholic University of Milan, and the University of Genoa. Bob gave the concluding paper at the Conference.

Our airport is served by Delta, Continental, and USAir from Philadelphia, Detroit, and Cleveland. It's small and VERY convenient, but book early as there are only so many flights. You won't spend more than 20 minutes from debarkation to rolling out your luggage. Look for a special welcome when you arrive.

The airport is 10 minutes from the hotel by cab (about a \$15-\$20 ride).

Mercyhurst is arranging vans for transfers; just e-mail Randall in the week before the meeting with your arrival info and we handle everything as long as you are getting in at a reasonable hour.

For those who want to come early and explore—there is a lot to do in the area—Randall has arranged an excellent rate from the Toyota dealer for new car rentals of \$29.00 per day.

Derek, their rental manager, will arrange for the car to be at the airport or they will pick you up. You will be able to leave it at the airport when you are done with it. The principal hotel, the Sheraton Erie Bayfront, is on Presque Isle Bay at the foot of the main drag in Erie. Randall has arranged a great price for attendees based on what we expect for attendance. The ordinary price for a room at the Sheraton is about twice the meeting rate of \$99.00.

## Minutes of the 2010 Business Meeting, Salt Lake City, Utah

Meeting was called to order at 5:15pm by President Lindsay Adams.

*In memoriam:* Adams called for a moment of silence in memory of Colin Wells, George Paul, and Martin Ostwald.

*Corrections to 2009 minutes:* spelling of Allan Samuels changed to Alan Samuel (Borza, Harl). Since copies of the 2009 minutes were unavailable, Pres. Adams asked any further changes to be sent to Sec-Tr.

### OLD BUSINESS:

*Publications Committee:* Lee Brice presented the report for the committee [Lee Brice (Chair), Carol Thomas, Gene Borza, Ken Harl, Tim Howe, Mark Chavalas, Jenny Roberts, Lindsay Adams (ex officio), and Steve Garfinkle (consultant)]. The next volume of PAAH (*New Directions in Military History*) is ready and anticipated for 2011 publication. Other publications are in the works. Those with ideas for future volumes, please contact Lee Brice, Lindsay Adams, or any of the committee.

### *Secretary-Treasurer's Report:*

(1) Membership: S/T Cindy Nimchuk noted that total memberships was at 693, up from 627 in the 2009 report; 596 US members (up from 540), 58 from Canada (up from 48, due to Vancouver meeting), 39 International, and 3 Life Members. That said, 258 members were behind on their dues (from 186 in 2009), and she reminded members to renew [134 members paid to end of 2009, 92 to end of 2008, 32 to end of 2007]. The website should help with renewals. The S/T has email addresses for 588 members (up from 512), and hopes this will continue to increase. Electronic membership stood at 200 members (up from 157), likely due to increasing web presence.

(2) Subvention Committee: S/T Nimchuk reported for the committee [Denise Demitriou, John Lee, and Cindy Nimchuk (*ex officio*)]. Four awards were granted this year, totalling \$1100.00. Graham Wrightson (U. of Calgary) received the Betty Coates Award this year. Additional recipients were Gaius Stern (Berkeley), David Lunt (Penn State), and Isabelle Pafford (Santa Clara U.). Nimchuk noted that Subvention funding was down and urged members to give generously!

(3) Finances: The balance of the Subvention Fund after the 2009 awards was \$17,324.49. Investment net gains were \$1387.12; Donations were \$545.00; awards granted in 2010 were \$1100.00. The Subvention Fund balance after the 2010 awards was \$18,174.61. The balance of the operating funds in Vancouver (2009) was \$20,436.78. From the 2009 meeting to the 2010 meeting, total income was \$4833.92 [Dues \$4137.81, Royalties \$641.88, Interest \$54.23]. Total expenses for that period were \$2466.75 [Newsletter Printing \$831.20, Postage \$474.69, Conference expenses \$721.26, Web services \$54.00, PayPal Fees \$100.51, Misc. Office \$285.09]. Balance of operating funds at the 2010 meeting in Utah was \$22,803.95. The S/T thanked everyone who helped as she learned the ropes. Report was unanimously accepted (Gaughan, Harl).

*Web Coordinator:* Patricia Dintrone reported that the AAH website is undergoing a gradual evolution with some content change. The newsletters can be accessed through the website. In addition, dues, general donations, and subvention donations can be made online through PayPal. New conference information and calls for papers will be posted as they are sent around on the list. Greg Anderson is working on the Directory of Ancient Historians, which will be placed online as soon as it is compiled. Suggestions and queries for the website can be sent to Pat Dintrone. [Discussion of the Directory of Ancient Historians followed, along with a reminder by Adams that a 'call for assistance' was placed in the newsletter, specifying the areas still needing coverage.]

*President's Report:* Pres. Adams thanked everyone for coming, given the economic constraints. He pointed out that the Annual meeting was the Heartbeat of the Association. Pres. Adams entreated members to donate to the Subvention Fund...the Fund was why there were so many new faces at recent meetings! He reiterated that new members are vital to our organization, and encouraged old hands to welcome and chat with the new folks if they hadn't already done so. Pres. Adams reported that future meetings looked rosy, with several offers lining up. He encouraged everyone that anyone could do the meeting; it took organization, but was fun!

### NEW BUSINESS:

#### *Future Meetings:*

(1) Howarth, in an animated presentation, reported on preparations for the 2011 meeting at Mercyhurst College, Erie, PA, including transportation, accommodations, and venues. Howarth issued the call for papers, noting that panel chairs would be responding to the papers (the call would also be published in the Fall newsletter, and in the list announcements).

(2) Fred Naiden issued an invitation on behalf of UNC and Duke to host the 2012 Annual Meeting (May 3 to May 6), with one day of papers at Duke, one at Chapel Hill. After the presentation of the amenities of the Triangle area, the invitation was unanimously accepted (Gaughan, Brice). Pres. Adams offered thanks to Naiden and the colleagues at UNC/Duke.

#### *Other:*

(1) Georgia Tsouvala has been appointed to the APA committee for Ancient History. She will meet with the committee in January, and urged anyone with comments or suggestions to get in touch with her. She noted that Serena Connolly is also on the committee and can be contacted as well.

(2) Leanne Bablitz initiated discussion regarding having members fill out a survey at meetings to gather feedback on the meeting and suggestions for future meetings. Pres. Adams and S/T Nimchuk volunteered to formulate a prototype. The proposal was voted on and passed (Brice, Gaughan).

(3) Stan Burstein moved to thank Lindsay Adams, the University of Utah, and the graduate students for a wonderful meeting and friendly hospitality. Unanimous applause! (Roberts)

(4) Adams thanked the membership and called everyone to gather at Mercyhurst College in 2011. He reminded everyone that the After Party would be in Room 303.

Meeting was adjourned at 5:55pm.

**CFP: Feminism and Classics VI: *Crossing Borders, Crossing Lines***

Ancient Mediterranean society was crisscrossed by multiple boundaries and borders. Firm boundaries between male and female, slave and free, gods and mortals (to name just a few) defined social identities and relationships, even as these lines were regularly crossed in religious ritual, social practices and artistic imagination. In current scholarship, Feminism is now Feminisms, encouraging multiple, and even transgressive, approaches to the study of women, gender, and sexuality in the ancient world. But has Feminism itself become a boundary, dividing fields of study or generations of scholars? Or is it a threshold, encouraging crossings between literary, historical and archaeological evidence? What new approaches are scholars using to push the boundaries of the evidence and the limits of our knowledge of the ancient world?

This conference will focus on boundaries, liminality, and transgression. What kinds of crossings did ancient people experience and what control did they have over such crossings? How did borders and border crossings differ in relation to gender, ethnicity, age, or legal status? If the masculine and feminine were clearly demarcated categories of being, how do we interpret homosexual, transvestite and gender-labile aspects of the ancient world? What points of contrast and connection exist between different types of gendered space (literal or metaphorical) and do they change when geographic or national boundaries are crossed?

We invite submissions for abstracts of papers and workshops that explore these and related themes, and encourage proposals from a variety of methodological and theoretical perspectives.
