Dear Colleagues,

I hope that you are enjoying a restorative and much deserved break! The past year has rightly been called *annus horribilis*. We faced social unrest, an unrepresented election, and a pandemic. We have lost colleagues, students, friends, and family members. When we met virtually in Iowa in April, we had been through a month and a half of lockdown orders and masks. Many of us did not imagine then that, months later, those would become “accessories” to our lives and outfits. In the months that have followed, we learned how to pivot from face to face classes to online breakout rooms in a day’s notice; we faced closures of libraries and archives while trying to forward our research agenda; we listened to the challenges and grief of our students and families; we juggled being teachers and parents, daughters and brothers, and partners to our beloved; we gave birth to children and to books and articles; we baked bread, organized our homes, and probably drank more than ever before. In mid-August, our Committee on Teaching (Eliza Gettel and Jeffrey Rop, co-chairs) held a successful on-line workshop on Pedagogy During the Pandemic. I would like to thank all the panelists and participants for supporting those efforts. You might be interested also in the Syllabi Database the Teaching Committee has put together; you can enrich this database for our field by donating your syllabi. Thanks also to Matthew Perry and the Subvention Grant Committee, and to Zachary Hertz and the Mentorship Committee, as well as to all of you who participate in the mentoring program either as mentors or mentees. Many thanks to Pat Dintrone (Technology) for maintaining our webpage, and to Andrea Gatzke (Social Media) for moving forward with the establishment of our social media presence. Since April, we have added 1,400 followers to our Facebook page alone!

Stanley Burstein offers this remembrance of Mortimer Chambers:



Mortimer H. Chambers, Jr. (January 9, 1927-December 14, 2020)

Mortimer H. Chambers, Jr. died on December 14, 2020, at the age of 93 following a brief illness. Although most of his life was spent in Los Angeles, Mort was originally a Michigander. The change began in the 1940s. After serving briefly in the US Army toward the end of WW II, Mort received his BA in Latin at Harvard, followed by an MA from Oxford made possible by a Rhodes scholarship, and a PhD in Classics from Harvard earned in 1954 with a thesis on *Studies in the Veracity of Thucydides* directed by Sterling Dow.

After brief stints as an instructor at Harvard and an assistant professor at the University of Chicago, Mort came to UCLA in 1958, where he taught for half a century. Throughout his long career he was a scholar-teacher. His specialty was the history and historiography of classical Athens. Mort's work was marked by thorough mastery of his subject and impeccable craftsmanship, so it is not surprising that his extensive bibliography includes classic articles on the "Themistocles Decree"; standard Teubner editions of the *Hellenica Oxyrhynchia* and Aristotle's *Constitution of Athens*; a fundamental monograph, *Aristotle's History of Athenian Democracy* that he co-authored with James Day; and his magisterial commentary *Aristoteles, Staat der Athener*. Finally, at a time in his career when most scholars would rest on their laurels, Mort produced important works in an entirely new field, the history of classical scholarship, including a model monograph on the life and times of the Greek historian Georg Busolt and important articles on Wilamowitz, Eduard Meyer, Felix Jacoby, Heinrich Schliemann, Francis Cornford, and Werner Jaeger.

Mort was also a master teacher. His lower division Western Civilization and upper division classes in Greek history regularly enrolled hundreds of students, attracted by his dynamic lectures and his legendary re-enactment of Hippocleides dancing away his marriage. His teaching also spilled over into his writing. The pamphlets on Greek history he wrote for the American Historical Association introduced a generation of teachers to the best of contemporary classical scholarship while his co-authored western civilization textbook, *The Western Experience*, went through ten editions. His teaching did not stop at the classroom door, however. His office was always open and the timid freshman asking for help in locating a translation of an obscure text, the senior working on his honor's thesis, and the graduate student struggling with his thesis could all expect a warm welcome and generous help. Mort was also a friendly presence at meetings of the Southern California Friends of Ancient History, welcoming young faculty and graduate students new to the area. He is survived by his beloved wife Catherine and his daughters, Pam and Julie; his son Blake predeceased him.
